☐ Pamlico (Flagship)

- New high-grade, volcanic hosted, near surface, oxide gold discovery in legendary district
- Untested potential for sediment hosted gold mineralization
- Exceptional infrastructure: modern decline, power, roads, etc.

South America: Colombia

☐ Yarumalito

- Drilled, large gold dominant porphyry and high-grade vein system both with multi-million ounce potential
- Amenable to heap leaching

☐ El Dovio

- Gold rich, polymetallic discovery
- Amenable to conventional flotation

- District scale (1670 hectares)
- High-grade gold discovery already confirmed by Newrange drilling

Exploration Highlights

- ❑ **Discovered 6 new high-grade gold Zones**
 - ❑ **High-grade, oxidized, shallow intercepts, including:**
 - DH P17-10: 6.1 m of 98 g/T Au (incl. 1.5 m of 341 g/T Au)
 - DH P17-17: 4.6 m of 44 g/T Au (incl. 0.8 m of 244 g/T Au)
 - DH P17-08: 9.1 m of 28 g/T Au (incl. 1.5 m of 85 g/T Au)

- ❑ **Identified disseminated / stockwork bulk tonnage potential**
 - ❑ **Near surface oxide “stock work” intercepts including:**
 - DH P17-17: 70.9 meters @3.57 g/T Au from 1.5 meters.

- ❑ **Defined NW-oriented gold corridor composed of multiple high grade zones contained within larger zone of stockwork mineralization.**

Round Mountain (Kinross)

- 2017 production: **437,000 Oz gold**




PAMLICO DISTRICT TARGET MAP
